Dr. Nitin Shah shared a report on the AFG Christmas Celebration held on 24th December at GCC, Mira Bhayander. The event was very well attended, with 60–80 participants supported by Sun Pharma.

I, Myself delivered a lecture on the surgical management of endometriosis. Dr. Nagarkatti presented a session on progesterone, followed by an engaging panel discussion on endometriosis and IVF featuring Dr. Rohan Palshetkar.

The Christmas celebration added a festive touch, thanks to Dr. Agrawal for arranging decorations and Santa caps. The evening also coincided with my 21st anniversary and Dr. Praveena Shah's birthday, marked with three cakes. Overall, it was a vibrant and successful program appreciated by all.

7) Discussion on future activities by Dr Nitin Shah

Dr. Nitin Shah informed the house that a program on IVF is being planned for 15th February 2025. Venue search is ongoing, but five-star options are proving to be very expensive. If arrangements work out, the final details will be shared on the group; otherwise the event may be deferred.

He also mentioned that a Basic Inventor Course (BIC) is tentatively scheduled for 1st March. Work is in progress for this as well.

8) Treasurer's Report by Dr. Jayanti Kamat

A total income of Rs. 43,000 was recorded — Rs. 3,000 from three additional live workshop videos and Rs. 40,000 received from Dolphin.

Total expenditure amounted to Rs.77,816. Payments included Rs.28,376 to Rabiya for the CMEs held on 13th and 24th December along with back-office administration of Rs.15,000.

Premises expenses were Rs. 11,806, and maintenance charges of Rs.12,624 were settled for October to December, which had been received later than usual.

Additionally, Rs.2,155 was paid by cheque to Dr. Saurabh for the AFG domain renewal, and Rs. 22,855 was spent on trophies.

After accounting for these transactions, the HDFC bank balance stands at Rs.10,61,855.

The meeting was concluded by the Secretary, **Dr. Bela Bhatt**, with a vote of thanks.
